## NON-DISCLOSURE AGREEMENT (NDA)

This Non-Disclosure Agreement (the "Agreement") is entered into by and between:

The 1<sup>st</sup> Party and 2<sup>nd</sup> party are each referred to herein as "Party" and collectively as the "Parties".

### 2. Type of NDA

**By Consent-** This Agreement shall be considered unilateral. Therefore the 1<sup>st</sup> Party shall have sole ownership of all information and shall be considered as Confidential or proprietary unless stated in writing. The 2<sup>nd</sup> Party is prohibited from disclosing confidential and proprietary information that is or has been released by the 1<sup>st</sup> Party

### 3. Purpose of this Agreement

#### Membership

**4. CONFIDENTIAL INFORMATION:** For the purpose of this Agreement, the term "Confidential Information" shall include but not be limited to documents, records, information and data (whether Verbal, written or electronic) relating to the Kingdom's Business. Confidential information has been designated as confidential or proprietary.

"Confidential Information" includes, but is not limited to:

- Trade secrets, business strategies, and proprietary information.
- Client information, including but not limited to customer lists, contact information, preferences, and transaction history.
- Financial information, including budgets, financial reports, and forecasts.
- Operational information, including procedures, Member data, and internal communications.

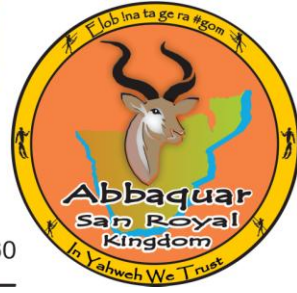

- Any other information disclosed by the KINGDOM to the members that is deemed confidential or proprietary.
5. **Return of Property Upon** the termination of your Membership, or upon request by the KINGDOM at any time, the Member agrees to return all materials, documents, or other items containing Confidential Information, including any copies, notes, or summaries thereof.
6. **Term of Confidentiality** the Member's obligation to maintain the confidentiality of the Confidential Information shall continue during the term of Membership and for a period of ten (10) years following the termination of Membership, regardless of the reason for termination.
7. **No License or Ownership Nothing** in this Agreement grants the Member any rights, title, or interest in the Confidential Information, nor does it grant the Member any license/permission to use Confidential Information except as expressly authorized by the KINGDOM in writing.
8. **Enforcement** The Member acknowledges that any unauthorized disclosure or use of Confidential Information may cause irreparable harm to the KINGDOM, and that the KINGDOM shall be entitled to seek injunctive relief, in addition to any other legal remedies, to prevent further disclosure or use of such information.
9. **Miscellaneous Governing Law:** This Agreement shall be governed by and construed in accordance with the laws of South Africa and the Constitution of the KINGDOM.
- **Severability:** If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.
  - **Entire Agreement:** This Agreement constitutes the entire understanding between the parties with respect to confidentiality and supersedes all prior discussions or agreements relating to the subject matter hereof.
  - **Amendment:** Any amendment to this Agreement must be in writing and signed by both parties.
10. **Acknowledgment and Acceptance** The Member acknowledges that they have read, understood, have initialed all pages and agree to the terms and conditions of this Non-Disclosure Agreement.
